Seymour-Goulburn Lions Bush Market at Goulburn Park , Guild Street, Seymour on Monday 12th March 2018

- Stallholder Entry: via Trevan Street (Caravan Park entrance) off Progress Street. Follow signs.
- Other Activities: Musical entertainment, children's activities, carnival rides and sideshows.
- Time: 9.00am to 2.00pm. **Stallholders must stay on site until 2.00pm as no car movements are permitted prior to this time for the safety of all.**
- Entry Gate: open from 6.30am. **SITES NOT OCCUPIED BY 8.00AM WILL BE RE-ALLOCATED**
- Site Size: 6 metres x 6 metres. **Book 2 sites if you need a site larger than 6m x 6 m**
- Site Fee: **\$45.00** per site received by Friday prior (09/03/2018). **\$55 for payment on the day.**
Sites must be pre-booked to guarantee an allocated site.

Food Vendor Site: **\$80.00** per site, must be pre-booked

- Food producers: Compliance to the Health and Safety Acts is required:-
1. All food traders (businesses and community groups) must be registered with 'Streatrader' for this event. Registration is available through <https://streatrader.health.vic.gov.au>. Please provide a copy of your registration with your application
 2. A completed gas safety checklist is required for your gas appliances. Completed paperwork must be submitted on arrival at the market.

 3. You must provide fire extinguishing equipment and hand washing facilities on your site.
